



REPORTING AND DASHBOARDS

Delonia's insurance platform includes a complete suite of reporting tools: from basic listing and search (exported to Excel spread sheets) to customizable charts, geographical representations, colour maps and many others.



These reports can be automated and programmed to be sent as system alerts, within a report subscription module.

The dashboards, or control panels, are special reporting modules that aggregate and publish global platform information.

These dashboards extend the functionality of reports and analytics, providing a Real-Time of each aspect of the company stored or managed from the Platform.



One example could be the reserve evolution, current status and currency exposure in realtime. It may be aggregated by country, LoB, Program or Claim cause.

Apart from providing actual information, evaluating positions and exposures, the information is presented on screen for an interactive experience:

- Filter the data, aggregate or decompose the different dimensions and categories.
- Drill-drown to get a higher detail of the information i.e. claim total cost per regions within a specific country.
- Obtain detailed lists of the claims / contracts responsible of certain information, such as high claim / premium rates.
- Establish threshold values on certain indicators or values, so the system generates alerts to management teams.

PROCESS OPTIMIZATION

By including metrics and KPIs in our solutions, specific reports and analytics may be extracted from these systems. Bottleneck identification, GAP analysis and opportunity discovery are some of the business optimizations that can be achieved.

INSURED SERVICES

Customers require services, regardless of the nature and properties of the insurance products they may have. And today these services are mostly based on technology.


We partner with specialized insurance and reinsurance business consultancy firms, when it's required a customized solution involving Pillars I & II of Solvency II regulation.


